- \_\_\_\_\_ 4. Public property such as signs and/or fire hydrants will not be tampered with.
- \_\_\_\_\_ 5. Trash and Recycling cans will be provided.
- \_\_\_\_\_ 6. Litter and debris will be cleared immediately after the event.
- \_\_\_\_\_ 7. Citations may be issued if excessive noise complaints are reported.
- \_\_\_\_\_ 8. The organization to whom this permit is issued and the people conducting the Block Party shall be responsible for the maintenance of good order on the premises during the Block Party.
- \_\_\_\_\_ 9. This permit may be canceled if any of the information supplied is not true or if any of the terms and restrictions are not met.
- \_\_\_\_\_ 10. The person requesting the permit must be present during the Block Party and is personally responsible for maintaining good order.
- \_\_\_\_\_ 11. The permit requester is personally responsible for the return of all borrowed items (barricades/cones/ etc.) **OR THEIR VALUE THEREOF.**

**Restrictions:**

- \_\_\_\_\_ Block Parties are limited to a maximum of twice per 12-month period
- \_\_\_\_\_ It is the responsibility of the permit requestor to ensure that all barricades are lighted after dark
